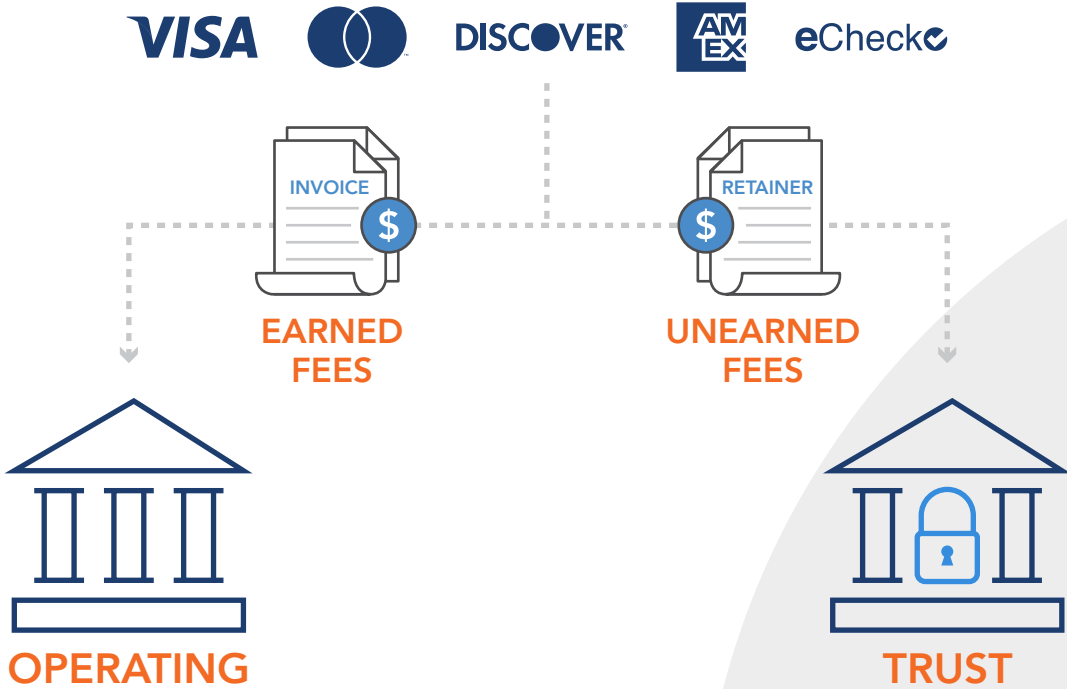

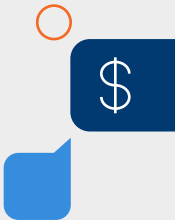

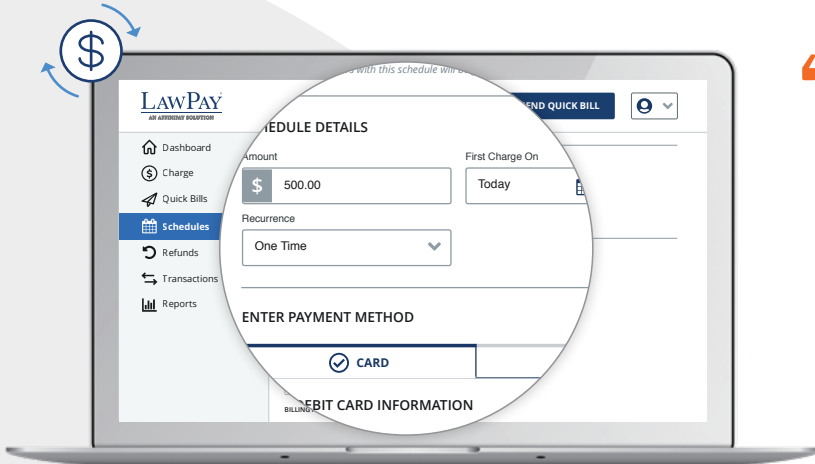

All unearned fees are deposited into your IOLTA account, while earned fees deposit into your operating account.

Funds in your trust account are not only separated correctly, but more importantly legally protected from all third-party transactions. No debits are allowed from your IOLTA at any time, for any reason. Processing fees are only debited from your operating account once a month.

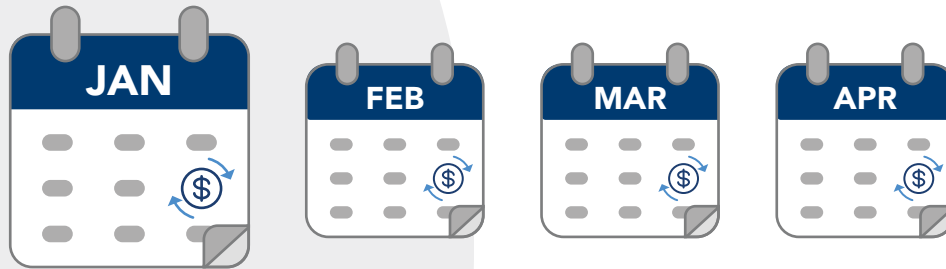

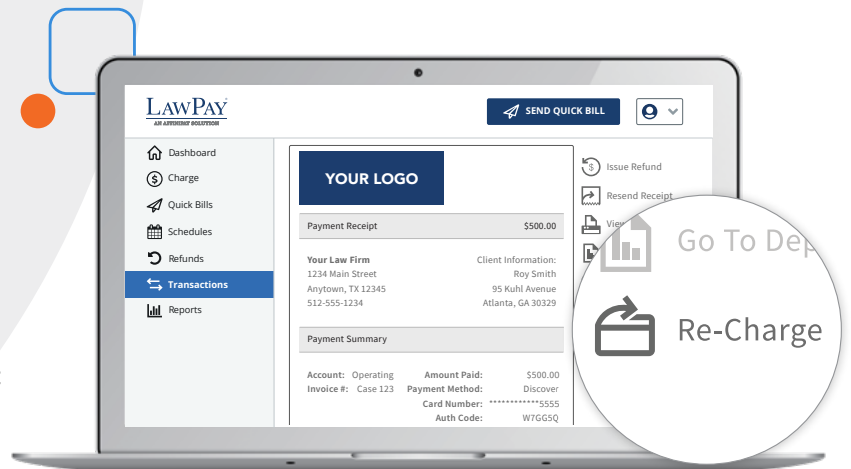
